COURSE DESCRIPTION The course starts and ends near the Holzer Sycamore Branch. It travels through GDC on Ohio Avenue, the bike trail between Haskins Park and Holzer Sycamore, as well as down 4th Avenue to a turnaround spot. The course is completed on a paved surface with gradual elevation changes in a couple spots. This is not a certified course.
